



## **RELEASE WAIVER AND INDEMNITY AGREEMENT**

To: ISS International School  
c/o 21 Preston Road, Singapore 109355

In consideration of you, ISS International School, arranging for my child (ward) to be conveyed to and/ or from school by means of a bus transport system on such terms and conditions as may be arranged and/ or agreed to by the school in its sole discretion and to which arrangement I do hereby agree to and accept as follows:

1. I understand and acknowledge that the bus transport contract is entered into between the school and myself, and I undertake to pay the school for the bus transport service at the rates prevailing within the stipulated period before the commencement of the required service.
2. I will be bound by the conditions set out and agreed to by the School on my behalf, with the bus operator, including any amendments that may be made thereafter.
3. I understand and agree that my child (ward) is conveyed to and/ or from school at the sole risk of my child (ward) and myself. The School is not responsible for any acts, defaults and/ or omissions whatsoever.
4. I agree that the School shall not be held responsible for any accident or personal injury howsoever arising, sustained or suffered by my child (ward), or for my child's (ward's) safety or death or any damage, loss or destruction to my child (ward) or belongings, however caused, while my child (ward) is being conveyed,



or is waiting to be conveyed, to and/ or from school to the fullest extent allowed by law.

5. I hereby irrevocably release and discharge the School from any and all claims, demands, costs, actions, or prosecutions in connection with any of the foregoing matters, including such action or omission to act that may be taken by the School prior or subsequent to the destruction of person or belongings.
6. In the event of any emergency, I do hereby authorise the School in its sole discretion to arrange such medical attention or treatment for my child (ward) as it may deem appropriate and available in the circumstance. I undertake to pay all medical hospital fees, expenses and incidental charges in respect of any and all medical attention whatsoever given to my child (ward) and to reimburse the School in full for any such fees, expenses and charges and all incidental costs and expenses which may have paid for the School in connection therewith.
7. I fully understand that I am not allowed to board any of the buses under the said transport service and should I do so under whatever circumstances, there shall not be any insurance coverage for myself. The School shall not be held liable or responsible in any way whatsoever or howsoever arising from any personal injury, death, damage, loss or destruction to person or belongings.
8. I agree to fully indemnify the School against any and all claims, demands, damages, costs, actions or prosecutions (including legal costs on a full indemnity basis) which my child (ward), his or her next-of-kin, parent, guardian, personal representative, dependents, authorities and/ or third parties may bring, make



commence or have against the School on account of any or all of the matters stated above.

9. I consent to the use of the personal data collected for the purposes in connection with the operation of the bus service and subject to the provisions of the Personal Data Protection Act (PDPA) and the ISS Personal Data Protection Policy found at [www.iss.edu.sg](http://www.iss.edu.sg).
10. I hereby warrant that I have absolute authority to execute this release, waiver and indemnity form on behalf of my child (ward) and that this release, waiver and indemnity shall be binding on both me and the child (ward) and all our heirs, assignees, representatives and successors.
11. Reference herein to the School shall include reference to the School as constituted from time to time, its officers, office bearers, employees, agents and other persons duly authorised by the School from time to time, but shall not include the bus contractor or operator, bus owners or their officers, employees, agents or others authorised to act on their behalf.
12. Words imparting the singular shall include the plural and vice versa. Any provision of this release, waiver and indemnity form which is held to be invalid or unenforceable shall be ineffective to the extent of such invalidity or unenforceability only without invalidating or rendering unenforceable the remaining provisions or parts thereof.
