



## **RELEASE WAIVER AND INDEMNITY AGREEMENT**

**Academic Year 2026–2027**

To: ISS International School

In consideration of ISS International School ("the School") arranging for my child/ward to be conveyed to and/or from school by bus, on such terms and conditions as the School may arrange or agree to in its sole discretion, I hereby agree and accept the following:

1. I acknowledge that the bus transport contract is between the School and myself. I undertake to pay the School for the bus transport service at the prevailing rates, prior to the commencement of service.
2. I agree to be bound by the conditions the School has established with the bus operator on my behalf, in its capacity as my agent for this purpose, including any amendments made from time to time.
3. I understand and agree that my child/ward is conveyed to and/or from school entirely at the risk of my child/ward and myself. The School accepts no responsibility for any acts, defaults, or omissions whatsoever.
4. I agree that the School shall not be held responsible for any accident, personal injury, death, or loss howsoever arising, sustained or suffered by my child/ward, nor for any damage, loss, or destruction to my child/ward's belongings, however caused, while my child/ward is being conveyed or is waiting to be conveyed to and/or from school to the fullest extent permitted by law.



5. I irrevocably release and discharge the School from any and all claims, demands, costs, actions, or prosecutions arising from any of the matters described in this Agreement, including any act or omission by the School occurring before or after any injury to, or death of, my child/ward, or loss of my child/ward's belongings.
6. In the event of any emergency, the School will make reasonable attempts to contact the parent or guardian before arranging medical attention. Where the parent or guardian cannot be reached and immediate action is required, I hereby authorise the School in its sole discretion to arrange such medical attention or treatment for my child (ward) as it may deem appropriate and available in the circumstances. I undertake to pay all medical, hospital fees, expenses and incidental charges in respect of any and all medical attention given to my child (ward), and to reimburse the School in full for any such fees, expenses and charges paid by the School in connection therewith.
7. I fully understand that unauthorized personnel, including parents, guardians, family members and domestic helpers, are not permitted to board any bus under the school transport service. Should any unauthorized person board the bus under any circumstances, there will be no insurance coverage extended to that individual, and the School shall not be held liable or responsible in any way for any personal injury, death, damage, loss or destruction to person or belongings.
8. I agree to fully indemnify the School against any and all claims, demands, damages, costs, actions, or prosecutions (including legal costs on a full indemnity basis) which my child/ward, their next-of-kin, parent, guardian, personal representative, dependents, or third parties may bring, make, or commence against the School in connection with any matter described in this Agreement.
9. I consent to the collection and use of my personal data for purposes connected with the operation of the bus service, in accordance with the Personal Data



Protection Act (PDPA) and the ISS Personal Data Protection Policy at [www.iss.edu.sg](http://www.iss.edu.sg).

10. I warrant that I have full authority to execute this Release, Waiver and Indemnity Agreement on behalf of my child/ward, and that this Agreement shall be binding on both myself and my child/ward, and on all our respective heirs, assignees, representatives, and successors.
11. References to "the School" in this Agreement include the School as constituted from time to time, and its officers, office-bearers, employees, and agents duly authorised by the School. It does not include the bus contractor or operator, bus owners, or their officers, employees, agents, or representatives.
12. Interpretation-Words in the singular include the plural and vice versa.
13. Severability-If any provision of this Agreement is held to be invalid or unenforceable, it shall be ineffective only to the extent of such invalidity or unenforceability, without affecting the validity or enforceability of the remaining provisions.
14. This Agreement is to be read together with the ISS School Bus Service Terms and Conditions for the relevant academic year. In the event of any conflict between this Agreement and the Terms and Conditions, this Agreement shall prevail in respect of liability and indemnity matters.
